CSQ Short Courses Subsidies—Explained

Construction Skills Queensland (CSQ) is an independent, not-for-profit, industry-funded body supporting employers, workers, apprentices, trainees and career seekers in the building and construction industry. CSQ provides funding to reduce the financial obstacle to training, making upskilling an affordable option for more individuals in the construction industry. CSQ-funded training is delivered by a range of selected registered training organisations (RTOs) across Queensland, including **Harness Energy**.

Terms & Conditions: To be eligible for CSQ funding, participants must meet all the participant and program eligibility requirements, as listed on the following page. These eligibility requirements include, but are not limited to, right to work, nature of current work, nature of prior work, and any current period of non-work. CSQ can change participant and program eligibility during the program term, and between funding years. CSQ caps funding available to organisations, which may limit the availability of some courses. Limits apply to the number of courses you can undertake during the offer period (1/10/2024 - 30/9/2025). Lifetime limits also apply to the total quantity of courses you can undertake with CSQ funding. Additional equipment costs may apply. Group courses are priced per person (exclusive of any special equipment hire). Subsidies are not available for units of competency where the participant has already undertaken the training. Locations where courses can be delivered are limited to the geographical areas of Greater Brisbane, Darling Downs - Toowoomba, and Central Queensland. Pricing is correct at the time of publishing but is subject to change—check the website for the latest pricing information. Gap Fees indicated are the net cost to participants after all funding claims. Courses must be fully paid for at the full rate, indicated on the Harness website, prior to course start.

CSQ Program Eligibility - Building Construction & Civil Construction

Funding can be applied if the following apply:

- Australian or New Zealand citizen; **or** Permanent Resident of Australia **OR**
- Visa Holder with relevant permission to work or study; **and** has been employed in the Building Construction industry for a period of 6 months or more, **AND** is

- Aged 15yrs or older (Civil), **AND** is

- Eligible Worker in Queensland, **OR** is
- Unemployed Eligible worker who has been unemployed for a period not greater than 6 months in Queensland

Funding is not available if the following apply:

- Undertaking this training as part of an apprenticeship or traineeship
- Employee of an Authority - except if the employer is a local council who is undertaking roles which would ordinarily be considered an Eligible Worker (Civil)
- Enrolled and participating in a QLD secondary school program.
- Contracted trainer or assessor or existing worker of an RTO.
- Funded by an authority or such other source for delivery of the same training being undertaken as part of this program.
- Funded for more than eight (8) short courses under this program (including both building or civil specific categories) in the same period.
- Funded for more than three (3) mobile plant operator (MPO) in the same program period.
- Verification of Competency is being sought.
- Prior completions. Either for the same training exists if the training is not an approved refresher course. Harness has no courses identified as approved refreshers for the 2024-2025 year. **OR** delivered via Recognition of Prior Learning or recorded as a credit transfer
- Funding claims - for otherwise eligible courses - are for courses completed before the program close on 30/9/2025 and are submitted prior to the 90 days allowed from unit completion.

Eligibility Evidence

Right to Work & Eligible Worker Documentation Required Includes:

Right To Work - evidence required:

- Green Medicare Card (current) or My.gov Medicare snapshot **or**
- Australian or New Zealand Passport (up to 6 months after expiry date); **or**
- Australian or New Zealand Full Birth Certificate (or extract*). *A commemorative birth certificate cannot be accepted. **or**
- Australian Citizenship Certificate. **or**
- Employer Letter (signed & dated by employer, on letter head) confirming participant has the right to work in Australia and undertake study, **and** the Visa Number, **and** the participant has been employed for 6 months or more in QLD's construction industry. *An international student visa cannot be accepted.

Eligible Worker - evidence required:

- If currently **Employed** in the identified industry priority needs and meet eligible worker criteria;
- Employer Letter (confirming employment, roles, and duties that demonstrate substantial engagement in the Industry sector priorities identified for eligible workers - must be on company letterhead and signed by employer); **or**
 - Relevant Current Licence (eg QBCC Licence) along with confirmation that the participant is undertaking duties that demonstrate substantial engagement in the industry priorities identified; **or**
- If **Unemployed** for less than 6 months from a role that would otherwise be an Eligible worker;
- Relevant Current Licence (eg QBCC Licence) along with Statutory Declaration (providing details of employment which would ordinarily be on the employer letter relating to role and duties). ; **or**
- If **Self-employed** and substantially engaged in the Queensland Building Industry;
- ABN/ACN registration (showing ownership and invoices for recent work in the industry); **or**
 - Statutory Declaration (providing details of employment including recent roles and duties within the Building and Construction Industry).

What is an 'Eligible Worker'?

You need to meet the industry priority needs as identified for eligible workers. These vary according to the industry category.
You are substantially engaged in the identified industry priorities:

Queensland Building and Construction Industry doing:

- Construction, significant renovations and extensions of, residential and commercial buildings
- Installation services for interiors of residential and commercial buildings in associated trades; electrical, plumbing, flooring etc.
- Works on a CSQ designated Major Project; construction of infrastructure

Queensland Civil Construction industry doing:

- Land development and site preparation for the purpose of construction
- Works for civil infrastructure
- Works on a CSQ designated Major Project; construction of infrastructure

Harness Energy's Major Project CSQ subsidised funding is only available as a nominated provider by the operators the CSQ designated major projects.
